If married out of community of property with ANC excluding accrual, the Applicant confirms that their spouse has no legal or beneficial interest in the business assets. This reflects the principle in *B F v R F* (GJ, 2018), where the court held that shares acquired during marriage formed part of accrual unless explicitly excluded.

If divorced, the Applicant must provide proof of divorce order and settlement agreement confirming that no ongoing claims exist against the business assets pledged to Cannexus. This requirement is consistent with *J.G.S v S.E.S* (WCHC, 2025), which clarified that unresolved marital claims can affect business transactions.

outside of Cannexus, Cannexus shall not be restricted, restrained, or prevented from pursuing its own business interests, expansion, or partnerships. Cannexus reserves

Page14 the right to proceed, decline, or suspend engagement if external activities compromise compliance, governance, or strategic alignment.

Cannexus does not position itself in competition with applicants' external concerns. However, Cannexus retains full discretion to determine whether parallel cannabis activities are compatible with its compliance framework and long -term objectives. Applicants accept that Cannexus may decline engagement if such activities present regulatory, reputational, or operational risks.
